Account Purpose: BUSINESS

Rate Information: The interest rate and annual percentage yield may change. At our discretion, we may change the interest rate on the account weekly. Interest begins to accrue on the business day you deposit noncash items (for example, checks). Interest will be compounded quarterly and will be credited to the account quarterly.

Balance Information: We use the average daily balance method to calculate interest on your account. This method applies a periodic rate to the average daily balance in the account for the period. Limitations: You must deposit \$100.00 to open this account. You may make six (6) transfers from your account per month, if by preauthorized or automatic transfer, or telephone (including data transmission) agreement, order or instruction. Transfers and withdrawals made in person, by mail, or at an ATM are unlimited.

Account Fees: You will be charged \$5 per month for any month in which your balance falls below \$500.00 daily balance.
